Dear Friends of the **SPCA Cincinnati**,



Speaking of "firsts," the **SPCA Cincinnati's Chow Now Pantry** is within that category. A volunteer-led program, the **Chow Now Pantry** has become a permanent part of our operations and will continue as long as there is an opportunity to serve. In 2022, we distributed over 62,000 pounds of free pet food to those in need, including our Military Veterans. Our goal is to keep people and pets together. 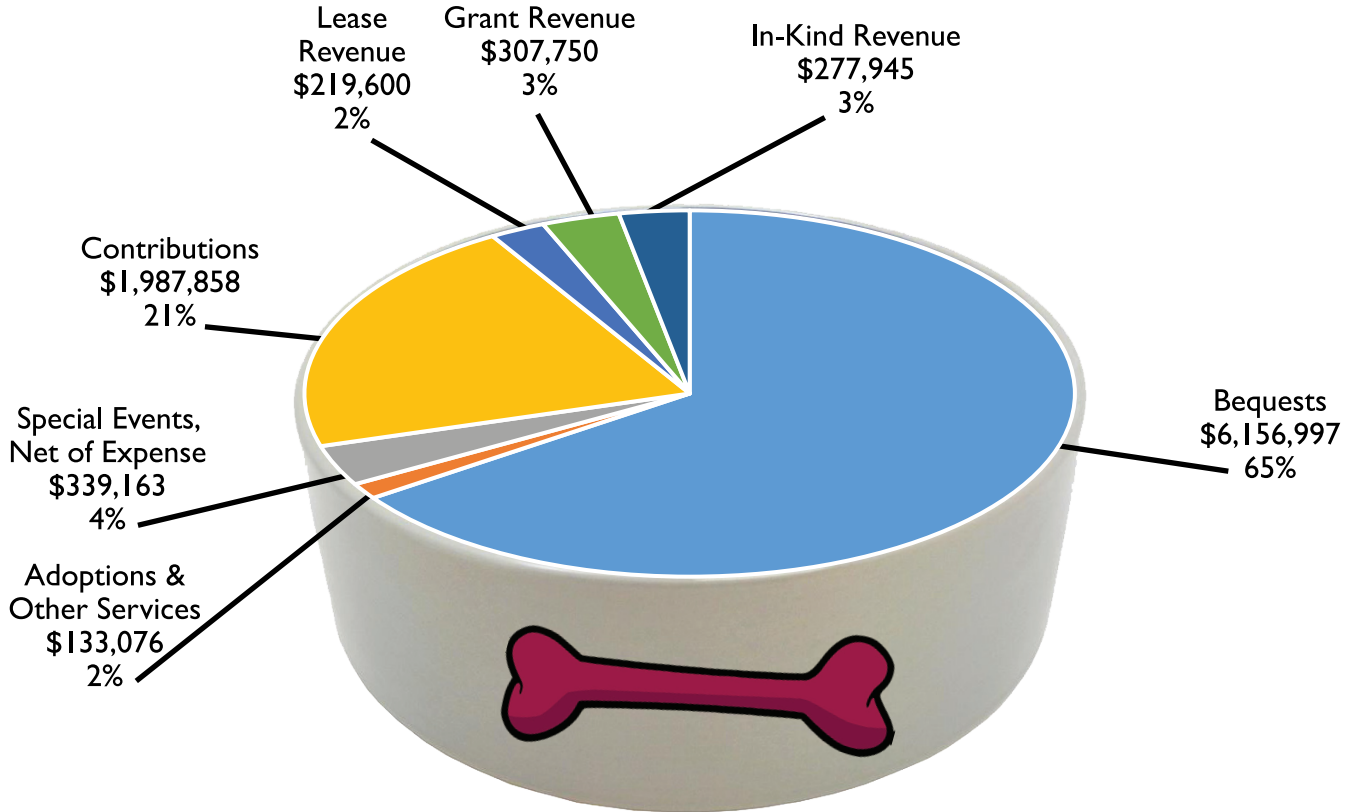

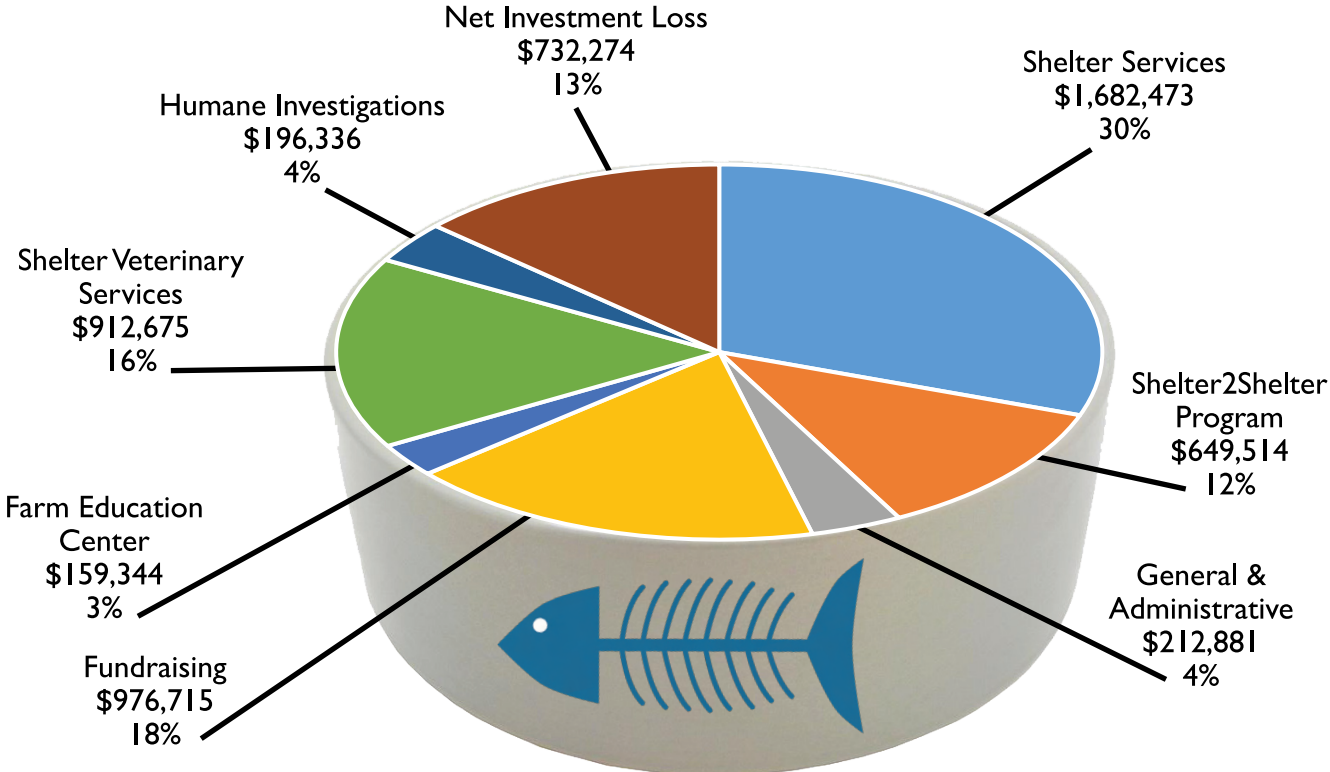
**2022 Income: \$9,422,389**

## MEDIA PARTNERS



Since 1873, the **SPCA Cincinnati** has saved countless animals. In 2022:

- More than **821** at-risk kittens received specialized care by staff, volunteers, and fosters
- **1,321** spay/neuter surgeries were performed
- **1,149** animals were transferred into the SPCA Cincinnati through its Shelter2Shelter transport program



- More than **521** animals in foster care
- Through partnerships with area rescues and animal welfare agencies, we transferred **198** animals from our facilities
- Through the generosity of donors, hundreds of adoptions were paid for through our Paw It Furward Program
